

# SCOTCH COLLEGE ADELAIDE Caledonian Scholarship Terms and Conditions

### 1. ELIGIBILITY

- 1.1 To be eligible for a Caledonian Scholarship at Scotch College Adelaide (the College), applicants must be Australian or New Zealand citizens or holders of an Australian Permanent Residence Visa who are:
  - 1.1.1 new students entering Years 7, 8, 9, 10 or 11
  - 1.1.2 current students entering Years 7, 8, 9, 10 or 11

A student is eligible for only one scholarship at any given time. Additional fee reductions cannot be applied.

#### 2. SELECTION CRITERIA

- 2.1 Student selection is based on an audition and interview, in combination with academic results.
- 2.2 Successful candidates must participate in a wide range of opportunities available at the College, respecting the values and policies that govern the College.

# 3. GENERAL EXPECTATIONS OF ALL SCOTCH COLLEGE SCHOLARSHIP HOLDERS:

- 3.1 Scholarship holders are role models and ambassadors of the College. They must demonstrate high standards of behaviour, leadership and presentation at all times. They must also set a positive example to the rest of the College; in particular those younger than themselves.
- 3.2 The scholarship holder should maintain a high commitment to their studies, demonstrated through a positive attitude, effort, and achievement.
- 3.3 Scholars must participate in an additional area of interest within the College.
- 3.4 The scholarship holder must consistently reflect the values of the College including honesty, integrity, leadership and inclusivity.
- 3.5 The scholarship holder must keep the amount of their scholarship confidential and not discuss it with other students, friends, or people outside their immediate family.
- 3.6 An annual review will be conducted to ensure scholars meet expectations.





- 3.7 The scholarship holder will actively participate in an annual review regarding their ability to meet the specified expectations of scholarship recipients.
- 3.8 If the scholarship holder does not meet the above requirements, the scholarship may not be renewed at the end of the academic year. In extreme cases, the scholarship may be withdrawn immediately.
- 3.9 A student can hold only one scholarship, which overrides any sibling discounts or special privileges.

# 4. STANDARDS, ACHIEVEMENT, ENGAGEMENT AND BEHAVIOURAL REQUIREMENTS All Caledonian Scholarship Holders must:

- 4.1 Adhere to the general expectations of all scholarship recipients.
- 4.2 Make a commitment to piping, highland dancing, or pipe band drumming.
- 4.3 Attend all lessons and practices and set a good example to other students.
- 4.4 Perform with the Caledonian Corps until the completion of their final year at Scotch.
- 4.5 Perform and compete solely with Scotch College unless permission is given for exceptional circumstances.
- 4.6 Demonstrate leadership as an ambassador for the Caledonian Pipe Band and encourage students to be involved in all piping events, both at Scotch and at external engagements.
- 4.7 Attend Caledonian Corps engagements.

## 5. CALEDONIAN SCHOLARSHIP AWARD AND ACCEPTANCE

- 5.1 Awards of Caledonian Scholarships over 50% may be made in exceptional circumstances. In such cases, parents may be asked to provide financial information to determine the additional level of support that may be provided.
- 5.2 The scholarship award applies to the relevant day College tuition fees. It does not apply to costs associated with uniform, iPad, transport, textbooks and stationery, additional excursions, co-curricular activities, private vocal or instrumental lessons, sundry charges and other personal items. The cost of these items must be paid in full by the scholarship holder's parents or legal quardians.





- 5.3 Scholarship recipients who are new students to the College must pay the application and enrolment fees upon acceptance of the Caledonian Scholarship. Current College students are not required to pay these fees.
- 5.4 Caledonian Scholarships are awarded on the expectation that the Caledonian Scholar will attend and complete their schooling at the College up to and including Year 12. If a Caledonian Scholar is withdrawn from the College prior to the completion of Year 12, the full value of the scholarship funds awarded for the period up to withdrawal must be repaid in full to the College. In extenuating circumstances, the College, in its sole discretion, may waive this requirement.
- 5.5 These Terms and Conditions should be read in conjunction with the College's applicable Student Enrolment Agreement, as amended from time to time.

#### 6. SCHOLARSHIP REVIEW

- 6.1 The College reserves the right to review the performance of the Caledonian Scholar at any time.
- 6.2 Caledonian Scholars will participate in progress reviews to ensure they are conducting themselves according to the expectations of a Caledonian Scholar. Caledonian Scholars will work towards meeting all progress goals established as part of the review process.
- 6.3 The College may review the terms of the Caledonian Scholarship or discontinue the Caledonian Scholarship in circumstances where the terms and conditions of the Caledonian Scholarship are not being met.
